BEARING WITNESS made a comfortable early lead, stayed in the two path around the turn and pulled away under a hand ride. KING XISCO chased between horses entering the turn, drifted out leaving the bend and was second best. SQUARED CIRCLE , fractious in the starting gate, raced in the two path on the turn and failed to menace. A LITTLE OFF , a forward factor outside horses, circle three wide around the turn and weakened. GAEL MY BOY broke slowly and was outrun. HENRY M hugged the inner rail chasing the winner and faltered.
