NOTTURNO tracked inside, was ridden into the far turn, bid from the two path entering the lane, led entering the final furlong, but drifted out and bumped an outer foe before the sixteenth, and held on. HEGS laid up close in the two path, was coaxed along around the far turn, bid while floating out to the five path at the top of the stretch, kicked on to sustain that bid into the final furlong, but got bumped by a drifting inner foe around the sixteenth, and could not go past. GO TAKE CHARGE broke out at the start, was unhurried in the two path, got put to a drive in the four path passing the three-eighths, angled out to the seven path in upper stretch, and rallied late to get up for show. GARDEN LEAVE steadied at the start, was wellback in the two path, ridden in the five path around the far turn, fanned out to the eight path at the top of the lane, and kept on. DOCTOR'S ORDERS stalked in the three path, was roused into the far turn, angled out to the five path in upper stretch, and stayed on, but was out-kicked. MAKOA raced in midpack along the inside, was roused passing the quarter, but finished evenly from the four path in the final furlong. MAYBE IT'S TIME a step slow at the start to race off the pace early, trailed up the backstretch, gained along the inside of the far turn, split foes inside the final sixteenth to improve position. ARCTIC OUTBREAK raced in the middle of the pack between foes, settled off the pace in the backstretch, made no further progress in the stretch. SASSE'S CLASS raced off the pace on the inside, loomed along the inside of the far turn to land a prominent position entering the stretch but came up empty. UPTOWN TAPPIN sat off the pace four wide throughout, failed to menace. KUNOOZ showed good early speed, held position up the backstretch, lost ground in the far turn to enter the stretch three wide before retreating. SILK WAR raced three wide in the middle of the pack, made no bid, quickly retreated to last in the stretch. AFTER A STEWARDS INQUIRY AS WELL AS AN OBJECTION LODGED BY THE RIDER OF HEGS AGAINST THE RIDER OF NOTTURNO FOR INTERFERENCE IN THE STRETCH, NOTTURNO WAS DISQUALIFIED FROM FIRST AND PLACED SECOND FOR DRIFTING OUT AND BUMPING HEGS AROUND THE SIXTEENTH POLE IMPEDING HEGS OF A FAIR CHANCE TO WIN.
