KHOKELA MISS was steadied at the start, made a quick move into the second turn, assumed command, drew off for a clear lead and held well. MISCHIEVOUS TWINS raced mid pack, was in tight entering the second turn, angled in for the drive, surged late and was gaining ground. DUTCHMAN'S MAP was pinched back at the start, advanced outside to the turn, swung wide into the stretch and finished well to earn show. JARNDYCE broke slowly, dropped inside to save ground, swung wide leaving the turn, found her best stride late and was gaining. SPRESSO MAR saved ground, awaited room on the turn and closed in traffic. IN THE WAKE came out at the start, was in tight entering the second turn, bid three wide to get in range and came up empty late. RUTHIE BAR raced close to the pace along the inside, bid off the rail, lacked room in the upper stretch and gave way. REPPAZZ raced close to the pace, had nothing left for the drive and faded through the stretch. QUEEN OFTHE COSMOS set a pressured pace and stopped into the second turn. ULTRA CAMEO pressed the pace, was in tight and checked into the turn and stopped. THE RIDER OF DUTCHMAN'S MAP CLAIMED FOUL AGAINST THE RIDER OF KHOKELA MISS FOR ALLEGED INTERFERENCE AT THE START. NO CHANGE WAS MADE.
