time in a determined effort. NOHAI stalked the leaders into the turn, rallied to vie with the pacesetter to mid-stretch, drifted out taking command in mid-stretch, ducked out sharply inside the eighth pole, straightened away and was caught in the final stride. GORTREAGH GAL shuffled at the start to be near the back well off the pace, worked his way back into contention and allied five wide in the lane with a belated bid to be along for the show. VAMONOS CHICAS tracked the leaders to be well placed at the top of the lane and lacked a closing kick in the stretch. RAMA BAMA LANA set a pressured pace, into the turn, shook off the presser only to be engaged by the runner-up nearing the quarter pole, battled that one to mid-stretch and weakened in the final furlong. BIG BOLT raced near the rear of the field to the stretch and passed weaker rivals in the lane. BELLA CREED was one-paced failing to menace. SOMETHINGTOSAY pressed the early pace and steadily faded from contention. CARTOON CITY was not a threat. DANCE ON AIR showed brief speed to be in early contention and gave way on the bend. SIX SHOOTER SUZIE was outrun. JENNY BK'S ON FIRE refused at the start, ducked when the gate opened losing the rider and walked off. THE STEWARDS POSTED AN INQUIRY INTO THE START AND DETERMINED JENNY BK'S ON FIRE RECEIVED A FAIR START AND WAS DECLARED A STARTER FOR WAGERING PURPOSES.
