## Footnotes | View Glossary Of Terms

GOLDEN CHAKRA set the pace under constant pressure, kicked away in upper stretch and dug-in gamely to hold late. JAVA TALES reserved in mid-field down the backside, angled in to the rail through the turn saving ground, cut the corner turning for home and closed well up the fence to just miss. GOD I NEED A FAVOR pressed the pace through the turn, rallied from five wide in upper stretch and kept narrowing the margin through the lane in a good try having to settle for the show. ASTRID was well placed tracking the leaders from the inside through the turn, angled four wide for the drive and lacked a closing kick running on thdown the lane. ECHALE GANAS raced mid-psck throughout and showed some mild interest in the stretch to just miss hitting the board. EIMEAR urged early to keep pace with the field, circled eight wide turning for home and showed some interest in the stretch. RY RY went evenly failing to menace. RUN CHACHY RUN slow early to be the trailer and passed weaker rivals coming home. MOM ESTERINA was not a factor. FORTY SEVEN SMOKER flashed brief speed up the inside to be with the pace and came up empty into the turn.
