LAW SCHOOL broke out, raced close to the pace, rallied on the turn to challenge for the lead, dueled to late stretch and drew clear under steady urging to prove best. HALF A DECK was pushed out at the start, pressed the pace, challenged on the turn, dueled for the lead, was no match late and finished second best. RIDGIE stalked between horses, angled out on the turn, went widest in the drive and offered a mild bid to earn show. CURLENE'S SPIRIT broke slowly and was crowded at the start, raced towards the back and improved position in an even effort. ENDLESS GLOW raced close to the pace along the inside, shifted out at the top of the lane, bid and came up empty. CAPRICORN BELLE set a pressured pace to the turn, dropped back and gave way. DON'T FOOL WITH ME was not a factor. JAVA TALES broke in the air to be off slowly, showed brief speed inside and was outrun.
