GOLD LIGHT pressed the pace on the outside up the backstretch, navigated the turn from the four path and kicked clear in the lane. MUTHABIR raced off the pace early, began a bid from the three path coming around the turn and chased the winner home through the stretch. LUNDI LOOT dueled on the inside up the backstretch, came around the bend in the four path, dueled in upper stretch and was outkicked in the final furlong. SCRAMBLER hopped up leaving the gate, settled in the middle of the pack between horses for the run up the backstretch, continued around the bend in the four path and finished evenly. CASEOFTHEMONDAYS raced in the middle of the pack on the inside up the backstretch, navigated the turn from the two path and showed no kick. MUNTAGE raced in the middle of the pack on the outside through the opening stages, swung out to the five path coming around the turn and was empty in the lane. RICKIE'S KIN dueled on the outside up the backstretch, dropped back while saving ground around the turn and continued to tire from there.
