WILLISTON WARRIOR broke on top then ceded the front, took up a stalking position three-wide while racing in hand, traveled well to the stretch while boxed in through the turn, tipped out to the three path in upper stretch, and quickly went clear when cued en route to a handy win. SUGAR ON FIRE broke well but to the inside and made contact with PERGAMON, then was always on or pressing the lead to the stretch, kept on well in the late stages despite racing on the wrong lead, was no match for the winner in the final yards, but saved the place. TUG settled widest of all down the backstretch but never far back, moved up three-wide through the turn while under a drive, came five-wide into the stretch and produced a grinding rally to get into the third spot. SHIFTHEWIND got away well and tracked inside just behind the pace battle, launched a bid from the three-furlong pole, loomed a major threat in upper stretch, then faltered in the final furlong. STONECOLDHANDSOME was hustled from the break to get a head in front early, contested the early pace three-wide, then was one of the trio to break free of the rest through the turn, was unable to keep pace from the quarter pole, and had little to offer in the stretch. PERGAMON mutually bumped hard with SUGAR ON FIRE after the start, was close up in the early pace mix to the half-mile pole, retreated from that point to be last on the turn, stayed on to the inside, and managed to outfinish a couple of rivals in the late stages. DON'T COPY ME broke with the pack, was close initially, then dropped back to last at the half, kept on late, but was unable to make an impact. GUNN'S ROAR was in a bit tight after the start, then vied between horses through the early stages, yielded midway on the turn, and tired late.
