FOMO JOE took control inside rivals early, cleared on the backstretch, met the bid from CIRCUIT BREAKER at the quarter pole, led in the two path turning for home, put that rival away midstretch and kicked away in the final sixteenth. CIRCUIT BREAKER stalked from inside, moved off the rail on the backstretch, challenged FOMO JOE at the quarter pole, could not match strides with the winner midstretch and kept on to earn the place honors. HONDO CROUCH showed early speed outside the leader then chased up the backstretch, came four wide into the drive and failed to produce a bid. PACER showed early foot three deep then took a stalking position around the bend, ridden along three deep into the far turn, remained three wide into the lane and weakened. BIG REFLECTIONS raced five then four deep around the clubhouse turn, continued wide up the backstretch, spun five wide into the lane and weakened. SKYQUIST sat off the pace outside a rival, angled out into the stretch and could not rally when called upon. CURLY'S AGENDA saved ground from off the pace, moved out in upper stretch and failed to menace. DAY MAN chased four deep into the first turn then pulled while moving to the two path,

angled inside on the backstretch, asked on the fence around the far turn and faded. REDIAL threw his head then hopped and hit the gate, trailed on the inside, moved out on the backstretch, asked three then four wide on the far turn and could not make an impact. THERE WAS A STEWARDS' INQUIRY REGARDING THE START OF REDIAL AND RULED THAT HE CAUSED HIS OWN PROBLEMS AND IS CONSIDERED A STARTER.
