MONEY RUN stumbled leaving the gate, went up to take the lead and showed the way in the two path then on the rail around the first turn, ridden along the inside then two wide again on the far turn, felt NAMELESS bearing down into the stretch, responded well to urging and dug in to turn the runner-up away in the furlong grounds. NAMELESS followed in range from inside to the far turn, tipped out and loomed three wide coming into the lane, failed to summon the needed late kick but was clearly second best. AUSTONIAN settled on the inside near the back of the field, moved off the rail and went between foes on the backstretch, advanced while moving back inside on the second turn, flattened out in the final furlong but was able to secure third. SEA DOG reserved early on next to the fence, gained leaving the backstretch but had to check when running up behind a rival early on the far turn, went two wide into the lane, angled out in upper stretch and kept on for a minor award. DEVILNTHEBLUEGRAS broke a step slow, reserved three then two wide early, chased in those paths around the far turn as well and could not threaten in the stretch run. UPSTART YANKEE settled two wide in the early going, angled in for the far turn, lost ground around the bend and weakened. ZIMBA WARRIOR trailed on the inside then moved to the two path, traveled three deep in the middle stages, went four wide into the far turn, angled out to the six path then came back to the four path leaving the bend and weakened. UNION WAVE chased four then three wide on the clubhouse turn, angled five wide around the second bend, eased in the lane and walked off. MOTHER'S PRAYER was closest in pursuit

from outside early, chased after the leader alongside a rival leaving the backstretch, retreated on the far turn, eased in the stretch and walked off.
