WARRIOR SAINT tracked from inside, came under a ride on the turn, took aim two wide leaving the bend, drew alongside the leader past the eighth pole, took over midstretch and won going away. FRACTIOUS broke a step slow, coaxed along the inside from off the pace, saved ground through the turn, moved off the fence in the drive, rallied and gained second. GRAND INDIAN was off slow to begin, chased well off the rail from off the pace, traveled four deep at the three-eighths pole, entered the stretch three deep and ran on to get up for third. ANOTHER WARRIOR sprinted clear and showed the way untested to upper stretch, confronted by WARRIOR SAINT inside the eighth pole and weakened once overtaken. DOUBLE D LITE was off slow to start, chased outside a rival off the pace, went three deep into the turn, raced greenly momentarily at the three-eighths pole, chased two wide into the stretch and failed to menace. HIGH AMBITION broke well then stalked outside a pair of rivals, between foes into the turn, took the turn two to three wide and weakened. CHARACTER bothered by LIBERTY N JUSTICE at the start, climbed early taking kickback, moved out four deep, chased three deep on the turn, two wide into the stretch and weakened. FREE LUNCH dropped back when climbing early, trailed into the turn, came five wide into the stretch and was never a factor. LIBERTY N JUSTICE broke alertly and inward, showed early quickness then raced greenly and dropped out of range, fell further back on the turn, went two to three wide into the stretch and faded.
