SILVERTOWN stalked for the three path, bid turning for home, drove clear in the two path entering the lane, shifted out at the sixteenth pole as an outer foe gave chase, got collared by that one in the late stages and narrowly held. RED RAINBOW led in the two path into the backstretch, vied with an inner foe approaching the far turn, then between rivals turning for home, got headed by her outer counterpart nearing the lane, shfted outside of that one in upper stretch, kept on to close in once more while getting subtly floated out into the final sixteenth, ranged up to offer a late bid but missed at the wire. QUEEN MCKINZIE chased from the two to three path then stayed on mildly to edge show from an outer rival at the wire. LEXICO stumbled severely at the start, raced off of the pace in the two path, progressed in the four path around the far turn to gain show at the quarter pole, but flattened out and got caught by an inner rival at the wire. RUMBAR raced close up along the inside, prompted before vying into the far turn, but yielded to an outer pair coming to the quarter pole and faded. SOUPERRAZZLEDAZZLE tracked from midpack along the inside, chased around the far turn then gave way. SWEETBITTERS bobbled subtly while off a step slow, trailed along the inside and got outrun. THE RIDER OF RED RAINBOW CLAIMED FOUL AGAINST SILVERTOWN ALLEGING INTERFERENCE IN THE FINAL FURLONG, BUT THE OBJECTION WAS DISALLOWED BY THE STEWARDS.
