IRISH LAW showed the way along the inside, got collared by an outer bidder at the five sixteenths pole, vacated the rail to duel with that one entering the lane, repelled that one while meeting an inner challenge at the furlong grounds then gamely turned away that one late. CLARK'S CORNER staked along the inside, awaited racing room fom the pocket around the far turn, vacated the rail momentarily at the quarter pole, moved back inwardly shortly after but shut off an inner SWERVE in the process, ranged up to bid inside of the leader at the furlong grounds, dueled shortly after but was turned away late. PROVIDER bumped with an inner foe at the start, pursue two wide, advanced with a three wide move at the half mile pole to bid outside of the leader while remaining in the three path at the five sixteenths marker, vied into the turn but was repelled in midstretch and proved best of the rest. MR. ALL IN tracked three to two wide, then between horses approaching the far tun, chased in the three to four path turning for home and failed to menace. BUCKLEY GOLD WATER bumped with an outer foe at the start, trailed along the inside, steadied to alter course around a troubled rival reaching the lane and failed to factor. KINGSPORT (IRE) pressed two wide, got outmoved by an outer rival into the far turn then weakened between horses nearing the lane. SWERVE saved ground off of the pace, got shut off and lost action while steadying hard leaving the quarter pole and was eased thereafter. THE RIDER OF SWERVE CLAIMED FOUL AGAINST CLARK'S CORNER ALLEGING INTERFERENCE NEARING THE LANE, FOLLOWING THE OBJECTION, AS WELL AS A STEWARDS INQUIRY, CLARK'S CORNER WAS DISQUALIFIED AND PLACED SEVENTH.
