UP THE CREEK stuttered a step at the start, stalked from the four path, bid and claimed an advantage entering the lane, drove clear shortly after then held sway. FINAL SHIPMAN raced forwardly along the inside, chased from the two path around the turn, shifted out to the five path in upper stretch and ran on to edge plac in the final sixteenth. MASCARA vied along the inside before prompting into and around the turn, rebid along with an outer rival entering the lane but proved no match for that rival and yielded. CAROL'S MELODY raced off of the pace near teh inside early on, steadied while bearing out into the turn, trailed in the two path in the aftermath, shifted in out in upper stretch and moved up. WILD ACCLAIM pursued from the five path and failed to menace. SPLIT SUCCESS raced off of the pace in the four to six path into the lane, shifted inwardly and lacked a bid. PULSTAR led in the three path, got headed by bidders on both sides entering the lane and faded. ASHKENAZI bobbled at the start, tracked from the three path and between horses, chased around the turn and tired.
