Guaranteed plus an additional \$87,500 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth
through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3%
to fifth. Weight: Three-Year-Olds, 122 lbs. Older, 126 lbs. Non-winners of a graded sweepstakes in 2026, allowed 2 lbs. A
sweepstakes in 2026, allowed 4 lbs. Starters to be named through the entry box by the usual time of closing. The race will be limited
to fourteen (14) starters. Preference to start will be given to graded stakes winners (in order I-II-III) then those horses having
accumulated the highest earnings in 2025-2026. Any horse excluded from running because of the aforementioned preference shall
be refunded the entry fee and the supplementary nomination fee if applicable. A trophy will be presented to the winning owner.

BANISHING vied in the three path and between horses, then only with his inner counterpart while remaining in the three path around the turn, drove clear in the four to five path in the final furlong then held sway from an inner pursuer late. DREAMINBLUE pursued from midpack two wide and between horses, shifted out to the five path entering the lane, ran on in the four path to gain place in the final sixteenth but needed more to reel in the leader. HERE MI SONG prompted along the inside early on, moved forward to secure inside position and vied inside of the eventual winner into and around the turn, yielded to that one while hanging on his left lead at the furlong grounds, changed over at the sixteenth pole then held show. ECHO AGAIN tracked near the inside, chased in the two path at the quarter pole then stayed on evenly. DR. SAIKALI saved ground off of the pace around the turn but to no avail. TRACK MATE trailed in the three path then moved up. ZERO SUGAR vied in the four path and between horses early on, but yielded at the three furlong pole and gave way around the turn. SPEED KING prompted from the five path, roused to sustain pressure in the four path into the turn but faded between rivals entering

the lane and weakened on his left lead. BOURBON BASH pursued from the five to six path then tired.
