CALL ON ME laid off of the pace in the three to two path into the backstretch, swung to the six path into the lane, rallied to reel in the leaders coming to the final sixteenth and drew clear. WINNING STREEP tracked two wide and between horses, tipped three wide around the far turn, bid at the quarter pole, led entering the lane but got caught by outkicked by an outer bidder with a sixteenth to go then gamely held place. PERRYLU raced close up along the inside while getting a bit keen around the first turn, settled into stalking stride down the backstretch, awaited racing room around the far turn, shifted two wide and between horse in midstretch then stayed on to be denied place. PRINCESS EM TOO settled in the three path after being put to tight quarters between horses around the first turn, advanced four wide into the lane, but got outkicked by an outer rival in midstretch and leveled off. LEINANI pressed two wide, got outkicked by an outer bidder at the quarter pole then gave way between horses. MECHAYA got keen behind foes into the first turn, pulled in pursuit along the inside around that bend, settled before moving between horses at the quarter pole, but encountered traffic and steadied behind foes in the three path entering the lane and lacked a rally. SWEET SURRENDER trailed along the inside, saved ground, swung out to the seven path in upper stretch and failed to factor. FROSTY MOJITO set the pace along the inside, got headed entering the lane and weakened. FOOTNOTE stalked four to three wide into the backstretch but faded in the four path around the far turn.
