ON PAR pressed the pace early on two wide, raced in the four path into the lane, took over command nearing the eighth pole and edged clear of foe in the final stages. MR. VAGGIO set the pace early on from the inside, stayed on the inside into the lane, kept up with the winner down the lane but finally yielded late in the drive. CARAGOGO tracked the pace early two wide, raced in the three path into the lane, came back late down the lane and finished willingly in the late stages. ASTAR was unhurried early on, raced off the rail into the lane, rallied down the lane from the inside with a late gain approaching the wire.

FINAL COUNTDOWN chased the pace early three wide, raced in the five path into the lane and ran on late in the stretch run. UNIQUE PERFORMANCE raced back early on, was in the six path into the lane, rallied wide down the lane with a mild gain late in the drive. DISMISS raced inside early on, shifted into the four path into the lane and leveled off late in the stretch drive. HOVLAND raced in the seven path into the lane and was never a factor. SMOOTH TRANSITION raced off the rail into the lane and was never involved. WHATAYASAY broke a tad slow at the start and was never a threat. MAGNIFIER was always outrun. BLESSED TOWN was a tad slow at the start and outrun.
