MANDY'S MAN CAN broke outwardly, prompted the leader from the four path, vied turning for home, led approaching the quarter pole and drew clear. TELECASTER set the pace in the two path as the eventual winner applied firm outer pressure, sparred with that one around the bend, got headed nearing the quarter pole then proved no match yet lasted for place. ROCKY RACCOON broke slowly, raced off of the pace two wide and between horses early on, two to three path around the turn, rallied into upper stretch, tipped out to the four path at the sixteenth pole and sustained progress to miss place. BOONESBORO came out at the start, stalked the top pair from the three path then only managed to chase before getting outkicked for show late. BIENVILLE pursued from midpack in the three to four path and between horses into the lane but failed to menace. TAPCON broke outwardly, raced off of

the pace in the three path and failed to factor. SIR VINCENT pursued from the five path then gave way. HELLACIOUS raced off of the pace along the inside and made little impact. RIDGE OF FIRE broke slowly, recovered to raced forwardly along the inside but faded around the turn. SAUDADE was reluctant to load, broke a step slow and got forced outwardly at the start, lagged behind and showed little.
