WINDY WALK took a bad step off a rival at the start, pressed the pace early on two wide, took over command, was in the five path into the lane, under a long drive down the lane and prevailed in the final stages. SWEET ALYSSA set the pace early on, raced in the three path into the lane, was under a long drive down the lane but did not have enough in the final stages. TIFFANY TWIST trailed the field early on, raced in the two path into the lane, made a bid in the stretch but flattened out along the rail late in the stretch run. SWEET CHABLIS tracked the pace early on, was in the four path into the lane and weakened late in the stretch drive. STORY HOUR stumbled badly at the start, stalked the pace early on, raced in the five path into the lane and leveled off late in the stretch. DARK DAHLIA was through after a half from the inside.
