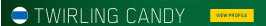

TWILIGHT DELIGHT set the pace in the two path, got collared between bidders at the five sixteenths pole, dueled with his inner counterpart into upper stretch, kept that one in tight quarters into the final furlong, shook clear whlie moving to the inside approaching the final sixteenth then held sway. LIVEHAPPY broke half a beat slow, stalked from the three path before tucking to the inside into the turn, progressed to bid inside of the leader passing the five sixteenths pole, vied with that one into the lane, but was put to tight quarters in midstretch, steadied back in the final furlong to alter out then kept on well. ZAP D'ETAT raced off of the pace in the three path and between horses, advanced in the four to five path into the final furlong, rallied while shifting wider and gained show late. DOUBLE TALKER stalked from the four path, bid outside of rivals turning for home, chased an inner pair in upper stretch, ran on to vie for place at the sixteenth pole but hung and got outkicked for show late. FRONTIER JUSTICE saved ground while in pursuit from midpack then chased one paced. VALIANT HUMOR broke a step slow, raced off of the pace in the four path, floated out to the six path leaving upper stretch and failed to menace. MOM'S SPAGHETTI saved ground off of the pace, encountered mild traffic in upper stretch and failed to factor. BLUE COAST raced at the rear in the three path, shifted to the five path around the turn before fanning to the seven path into upper stretch, and made little impact. MAGIC BREW pressed the leader from the three path, then between horses at the five sixteenths pole and weakened. THE RIDER OF LIVEHAPPY CLAIMED FOUL AGAINST TWILIGHT DELIGHT ALLEGING INTERFERENCE IN THE STRETCH RUN, BUT THE OBJECTION WAS DISALLOWED BY THE STEWARDS.
