TIZ GRAZEN was reserved off the pace, moved up three-wide nearing the quarter pole, came in slightly to bump with DEPUTY'S DAMCER nearing the sixteenth pole and prevailed narrowly. DEPUTY'S DANCER set the pace under early pressure from OUR BLOKE, then came out slightly to bump with TIZ GRAZEN nearing the sixteenth pole and held on gamely to the wire. PISTOL POWER was allowed to settle, came three-wide into the stretch and finished in a mild rally. OUR BLOKE prompted DEPUTY'S DANCER early racing along the inside and weakened. GIANOLA reared badly at the start to get away well behind his field and failed menace. THE STEWARDS CONDUCTED AN INQUIRY INTO THE START AND RULED THAT GIANOLA DID NOT RECEIVE A FAIR START AND RULED HIM A NON-STARTER. THE TRAINER OF DEPUTY'S DANCER LODGED AN OBJECTION FOR INTERFERENCE IN THE STRETCH BUT AFTER VIEWING THE FILMS THE STEWARDS MADE NO CHANGE IN THE ORDER OF FINISH,
