TIGER LADY vied WITH PRANCIN LADY from along the outside, responded when asked and edged clear late. ANNIKA'S SONG was forwardly placed racing three-wide, moved up to offer a bold bid nearing the eighth pole but was unable to match strides with the winner late. SWIFT CARO was allowed to settle early, moved up four-wide nearing the quarter pole and finished strongly. PRANCIN LADY vied with TIGER LADY for the lead from along the inside to the stretch and weakened. CAPE BLOSSOM hopped at the start then settled in the back of the field, came three-wide into the stretch and failed to seriously threaten. COIFFEUR was allowed to settle, came two-wide into the stretch and failed to be a factor. CHATTY LEROYBROWN saved ground racing in the middle of the field and tired.
