TAINO HOUSE vied with MOJAVE for the early lead, shook that one off to open a clear lead nearing the eighth pole and maintained a safe advantage. ROLL DEM BONES saved ground while being allowed to settle, angled out to be four-wide nearing the eighth pole and closed strongly. NATION OF FAITH raced in the middle of the field while two-wide, swung out to come five-wide into the stretch and finished in a mild rally/. DISCO DANZING was unhurried, rallied three-wide into the stretch, angled in nearing the eighth pole and went evenly late. TIME TICKER settled in the back of the field, rallied five-wide into the stretch and improved his position/. BLACKJACK AND BEER was three-wide racing in the middle of the pack and lacked a rally. MOJAVE vied with TAINO HOUSE racing two-wide for the early lead and tired. STEPHEN JAMES chased the early pace racing thjree-wide and gave way.
