BROTHER O' BRIEN was unhurried, moved up four-wide nearing the quarter pole, came five-wide into the stretch, gained a slight lead nearing the eighth pole then dueled with J. B. BOOKS from that point and was fully extended to prevail. J. B. BOOKS raced in the back of the field, rallied three-wide into the stretch to offer his bid, dueled with BROTHER O'BRIEN from along the inside and just missed. BENNY BUCKETS was allowed to settle racing two-wide, continued to be two-wide entering the stretch but was unable to stay with the top two. EL JOY prompted the pace racing three-wide, came two-wide into the stretch and finished well in a steady effort. BLAZING PEME was forwardly placed racing three-wide, came four-wide into the stretch and lacked a rally. CAUSE FOR DIVORCE was two-wide racing in the middle of the field, came four-wide into the stretch and was not a factoir. NO ORDINARY TIGER vied for the early lead with RIGHT HAND RYDER from along the outside and weakened. RIGHT HAND RYDER vied for the early lead from along the inside and tired then was transported off the track via the equine ambulance.
