KINKY MOON saved ground racing in the back of the field, angled out to e=be two-wide nearing the eighth poke and was up in the final sixteenth to win going away. COIFFEUR was reserved early, swung out to come five-wide into the stretch and finished strongly for the place. CUT N CURL was unhurried, came six-wide into the stretch and finished in a mild rally. KIR ROYALE was prominently placed racing three-wide, moved up to take a slight lead nearing the eighth pole but wasn't good enough in a steady effort. SWIFT CARO was three-wide racing in the middle of the field, came four-wide into the stretch but lacked a rally. BUMPING RIVER vied with COCONUT DREAMS from along the outside to the stretch and weakened. ARMY KNIFE was allowed to settle racing two-wide and tired. COCONUT DREAMS vied with BUMPING RIVER for the lead into the stretch from along the inside and gave way during the drive.
