CAUSE FOR DIVORCE disputed the early pace racing three-wide, gained a slight lead nearing the quarter pole and edged clear late. AT THE CROSS vied for the lead with REGARDING HARRY from along the inside, responded during the drive and held on well for the place in a game try. HATAGASAL was allowed to settle, rallied four-wide into the stretch, offered a bid at the eighth pole and then hung. ALOHA CHROME raced in the back of the field, came five-wide into the stretch and rallied late. IT'S TIME saved ground while being unhurried, angled out three-wide nearing the eighth pole and finished in a mild rally. REGARDING HARRY vied for the early lead form between horses and tired.
