SIMONSIITO with the pace from the start inside, edged clear after disposing of the other early speed early in the turn, responded when the runner up came calling from the outside entering the stretch, spirited duel to the wire, dug in late to narrowly prevail in game fashion. CONVEY TO ME stalked the early leaders while racing three wide, advanced and engaged the winner from the outside turning for home, long duel to the wire, outgamed in the final strides. LORD OF LIGHT back off the pace well out in the strip, four path through the turn, proved no match for the top two in the final furlong. MORRO MORRO dueled up front outside the winner for a quarter then began a steady retreat.
