I'M A DUDE TO saved ground setting the pace and increased his advantage. HAKA was forwardly placed racing four-wide and finished well for second in a steady effort. BARKLEY'S IMAGE saved ground while being allowed to settle, slipped through during the drive and finished in a mild rally. HEZ ALL SMILES was prominently placed racing three-wide on the turn but lacked a rally. HELA FOREVER chased I'M A DUDE TOO early racing two-wide, steadied from between horses in tight nearing the five-sixteenths pole and finished willingly when clear. CONVEY TO ME was forwardly placed to the quarter pole racing along the inside and tired. STACY'S STAR dropped back early and trailed. THE JOCKEY OF HELA FOREVER LODGED AN OBJECTION AGAINST BARKLEY'S IMAGE AND THE STEWARDS ALSO CONDUCTED AN INQUIRY INTO INCIDENT NEARING THE FIVE-SIXTEENTHS POLE BUT AFTER VIEWING THE FILMS FOUND INSUFFICIENT INTERFERENCE TO WARRANT A DISQUALIFICATION,
