STAY LIT was unhurried early, rallied four-wide into the stretch, split rivals leaving the three-sixteenths pole to join the leaders and gradually edged clear late. DENNARD saved ground early while being reserved off the pace, rallied six-wide into the stretch and finished strongly. J T'S WATCH was forwardly placed while racing two-wide and finished well in a steady effort. MOUNT PELLIAR hopped at the start then raced in the back of the field, came eight-wide into the stretch and rallied late. MOVE OVER (GB) settled in the middle of the field early, moved forward nearing the quarter pole while four-wide, came seven-wide into the stretch but lacked a rally. ORTH prompted the early pace racing three-wide and weakened. HOWDOYALIKEMENOW vied for the lead from along the inside into the stretch and tired. CANDY'S WILDCAT vied for the lead racing two-wide to the stretch and gave way late. HAPPY DOES raced in the middle of the field early while two-wide and was not a factor.
