ROBIN RACER saved ground while being reserved off the pace, angled out to be three-wide splitting rivals entering the stretch, took the lead nearing the eighth pole while coming in slightly and drew clear late. VINO VIKING was off a step slow then unhurried, rallied seven-wide into the stretch and closed strongly. LEAD THE CHARGE chased the early pace racing along the inside, slipped through entering the stretch, ducked out late and finished well in a good effort. CANTCATCHTHISCAT steadied nearing the three-quarter pole when MOONLIGHT SERENADE came out then was allowed to settle, rallied five-wide the final quarter and finished willingly. SAINT BENJI was allowed to settle racing two-wide, came four-wide into the stretch but lacked a rally. COASTAL JOURNEY vied with WRECKLESS RHETT for the lead from along the outside, came four-wide into the stretch and weakened. TAPBYANGELS prompted the early pace racing three-wide and tired. ASHRYVER was unhurried early, came three-wide into the stretch and failed to seriously threaten. WRECKLESS RHETT vied for the lead from along the inside to near the stretch and gave way. MOONRISE SERENADE got out badly nearing the three-quarter pole then dropped well back, was eased and walked off following the race. THE TRAINER OF LEAD THE CHARGE LODGED AN OBJECTION AGAINST ROBIN RACER BUT AFTER VIEWING THE FILMS THE STEWARDS RULED THERE WAS INSUFFICIENT EVIDENCE TO WARRANT A DISQUALIFICATION.
