JULIA'S WARRIOR unhurried in the beginning, made a steady gain, dueled down the lane and prevailed for the win. LUNI SIMA lacked early speed, came around the turn on the outside, entered the stretch wide, made a bid down the lane and finished willingly. SONOFASHIP went to the front, drove clear, saved ground and lacked a late kick. TAPPIN FORA DANCE raced within contention, saved ground around the turn and finished evenly. SONO pressed the pace, forwardly placed throughout, weakened and lacked a kick. PINEDALE raced within contention, came around the turn on the outside, faded and finished evenly. DRIED PEPPER showed early speed, dropped back and was no threat late. WILLIAM GUSTAVO raced evenly near the back and was never a factor. SANPIRODU lacked early speed and showed little. BILOXI always raced near the back and was outrun. SUPREME CAPO raced within contention, dropped back and was outrun.
