CLEARLY STARDOM dueled on the front end, drove clear and held on well for the win. BROCK'S BOY lacked early speed, made a steady gain, rallied wide down the home stretch and closed well. MISCHIEVOUS SMILE vied for the early lead, saved ground around the turn, came out down the stretch and held the show position. MIRACLE ON CENTRAL raced within contention, forwardly placed throughout, steadied down the stretch after MISCHIEVOUS

SMILE came out into his path and was outfinished for show. THE PETITIONER raced in the middle of the field, came around the turn on the outside, made a mild bid and hung. YOUcandoITBOY lacked early speed, showed late interest, while racing wide, but was no factor. HOWIEWIN raced in the middle of the pack and was never a threat. SHERKHAN raced in the middle of the field, saved ground around the turn and weakened. SAILOR MIKE always raced near the back and showed little. HILLBILLY'S HEART void of early speed and was never close. AZTECA MIA lacked early speed and was outrun. A STEWARDS INQUIRY WAS CALLED INTO THE STRETCH RUN OF THE RACE AND ALSO THE JOCKEY OF #1 MIRACLE ON CENTRAL LODGED A CLAIM OF FOUL AGAINST #6 MISCHIEVOUS SMILE FOR INTERFERENCE AT THE HEAD OF THE LANE. AFTER VIEWING REPLAYS STEWARDS DISQUALIFIED #6 FROM THIRD AND PLACED HIM FOURTH.
