STONE ALLIANCE raced within striking distance, moved up around the second turn, angled out entering the home stretch and proved the best late. RUNFORJUSTICE dueled for the early advantage, raced close throughout and was outfinished for the win. MY DAD'S GUITAR unhurried in the beginning, moved up on the inside around the final turn and proved no match for the top two. KEE JEE lacked early speed, came around the first turn on the outside, gained ground late, but was no factor. GIVE ME A TRY dueled on the front end, saved ground and weakened. HUDSON'S DAY raced within striking distance, faded and finished evenly. CONTRABAND EARLY raced within contention, made a bid at the 3/4 pole and dropped back. MR. RONNIE raced in the middle of the field, had an outside trip, faded and was outrun. EASY EDDIE A always raced near the back and showed little. SABERMAN void of early speed and was never close.
