BABY ZONG settled in the back of the field early, rallied four-wide into the stretch, angled out to be six-wide nearing the eighth pole and finished fast to be up in the final sixteenth. HE'S READY TO WIN dueled for the lead from along the inside with REDREBELPRODUCTION and SEVERUS SQUALL, responded to pressure during the drive and held on gamely for the place. RUNNER RUNNER was prominent early, came between horses into the stretch while three-wide and finished in a mild rally. CADILLAC BO was forwardly placed racing four-wide but lacked a rally. SEVERUS SQUALL prompted the pace racing three-wide, drifted out slightly nearing the stretch and weakened. REDREBELPRODUCTION dueled for the lead into the stretch from between horses, came in nearing the eighth pole taking the path of HE'S A REAL OUTFIT and tired. HE'S A REAL OUTFIT saved ground while being allowed to settle, checked nearing the eighth pole when REDREBELPRODUCTION came in and finished willingly when clear. THE PETITIONER was unhurried, came five-wide into the stretch then bled and was pulled up in the upper stretch and transported off the track via the equine ambulance. THE STEWARDS CONDUCTED AN INQUIRY INTO THE RUNNING OF THE RACE AND AFTER VIEWING THE FILMS DISQUALIFIED REDREBEL PRODUCTION FROM SIXTH AND PLACED HIM SEVENTH.
