SHADOW DANCER set the pace, drew off on the turn for a clear lead and held safely under mild urging. CUSTOM VALUE raced in close to the turn, lacked a late response and was no match for the winner. CANDY GIRL MISS pressed the pace to the turn, dropped back, finished evenly and held safely for show. FAYE L. brushed at the start, saved ground, bid inside and had nothing left. ANCHO failed to threaten in an even effort. VE NINA was void of early speed and passed tiring rivals. SIERRA HILLS hesitated and was crowded at the start, had an outside trip, showed speed to the turn and stopped. MR LEE'S PRINCESS broke out, was always outrun and showed little. TIMEFORMARGARITAS raced close to the pace along the inside, dropped back on the turn and stopped. TALK had brief speed only. MY GIRL SCOUT brushed at the start, was through early, stopped and was not urged late.
