YOCKEY'S DRIVETHRU rallied into the turn, closed willingly, got up near the sixteenth pole and drew off. LOUISIANA JESS was unhurried early, went six wide leaving the turn, found his best stride late, was gaining ground and earned place. COATTAILS got away alertly, dropped in, vied to mid stretch, inched clear, was outclosed and settled for show. DADDY'S CODE stalked the pace along the inside, angled out on the turn, challenged for the lead, dueled to mid stretch and faltered. BOY CHARLIE lagged early, angled out at the top of the stretch and offered a mild bid to improve position. RUNNING RAGGED was never far back, lacked a closing response and faded. CUT DAY stalked the pace to the turn and flattened out. METALLIC MISCHIEF had brief speed only. MAJESTIC PALACE was slow early, awaited room on the turn, altered course at the top of the lane and lacked a response. MY CHULUPA put in an even effort and was not a factor. C F SPUNIE STYLE moved up inside, vied to the turn and stopped.
