FAMILY CREED duelled on the lead from between horses early, continued to battle gamely from the fence to mid-stretch and was outkicked late in the drive. SKIPPA pressed the pace to the top of the lane and weakened. HALF MAGIC was a step slow a few strides from the gate to trail early, was hustled up to contention down the backstretch and finished evenly. ORDER UP flashed brief speed up the rail and gave way entering the turn. HEZA SEXY ZONG was not a factor.

GOTTATAKEHIMTO slow early to trail into the first turn, gained position up the fence down the backside, waited patiently on the final bend while saving ground, tipped out two wide splitting rivals turning for home and closed best of all in a blanket finish. IT'S A BIRD unhurried for the first half mile to trail the field, closed ground on the turn rallying five wide and was gaining through the lane to come up just short in a good effort. QUARTER RAT prompted the pace the entire trip, made a three wide bid turn for home and was outfinished in the final strides. PAYOFF CYCLE set the pace under mild pressure to the quarter pole, responded for the drive and weakened late in the lane. INSPECTOR ED well placed tracking the pace from three wide to the head of the lane and gave way down the stretch. CAJUN CONNECTION was eased at the quarter pole and vanned off.

SWEET LITTLE ROSE reserved off the pace to the quarter pole, rallied from three wide at the top of the lane, was taken up midway down the stretch when rival drifted into her path, angled in upon being gathered up and finished with mild interest. CHERRY STAR failed to menace. NATURALBORSENDER raced in contention for a hlaf and stopped in mid-stretch. CRYPTO BRAVE showed brief speed to be well palced for the first quarter, dropped to the rear of the field on the turn and was not a threat. THE STEWARDS POSTED AN INQUIRY INTO THE STRETCH RUN AND UPON REVIEW DISQUALIFIED MY LUCKY BREAK FROM SECOND TO FIFTH FOR INTERFERENCE WITH SWEET LITTLE ROSE.
