ROBERTS REVENGE unhurried early to be near the rear of the field, commenced a strong rally midway on the turn to sweep up from six wide in the lane and be going away late. D'BUSKER pressed the pace to the head of the lane, took command midway down the lane and was caught by the fast closing winner late in the drive in a good effort. LA PALABRA set the pace under steady pressure, briefly opened the advantage nearing the quarter pole, battled to late in the lane and weakened. APPEAL was well placed in striking distance throughout and lacked a closing kick. SWEET THIRTEEN was slow early to trail to the quarter pole and showed good interest in the lane with a late rally. CHARGE THE DEAL stalked the pace for a half and flattened out inside the eighth pole. WON BRIGHT LIGHT went evenly failing to menace. SAUCY GEM chased the pace and was through after a half. LEXI'S FURY passed weaker in the stretch never posing a threat. BABY JANE was not a factor. CLASSY MIMI raced mid-pack to the turn, mounted a mild bid on the bend and gave way.
