PERRY COUNTY set the pace, drew off into the stretch for a clear lead and held well in a driving finish. FUNNYFLAME was unhurried early, rallied around the turn, went widest in the drive and found his best stride late. SPECIAL MEMORY raced in the second flight along the inside, rallied into the turn, closed steadily, didn't have enough late and earned show. MASTEROFFOXHOUNDS vied for the lead, dropped back entering the stretch, hung late and lost position. MR MCGREGOR raced mid pack, advanced on the turn, bid and came up empty. ESCAPE ARTIST trailed the field.
