Footnotes | View Glossary Of Terms

HOUSE BOURBON showed good early foot to control the early pace, dug in deep stretch and proved best in a determined run under all out pressure. PLAY MO stalked the pace two deep down the backstretch, took aim on the winner four wide near the three sixteenths pole but could not get by in a game effort. MI SOLUTION prompt the early leader from the inside and kept on to the wire. TONTERIA stalked the pace, raced two to three wide between rivals nearing the sixteenth pole and kept on willingly to the wire. GET THEM JUSTIN settled off the early pace, raced from the inside into the upper stretch and needed more in the drive. COFFEE COUNTY void of early speed, swung wide into the lane and had not enough. TOTALLY ADDICTED was off slowly, raced from the inside near the quarter pole and never threatened. INCHHIGHATAHUNDRED raced mid pack early on, raced three deep around the far turn, tipped out five wide into the upper stretch and never threatened. CAJUN AMI failed to sustain a bid. ORDER UP saved ground and never was a factor.
