LAMMAS (GB) raced close to the pace along the inside, bid along the rail on the turn, closed steadily and wore down MASTEROFFOXHOUNDS to get up near the wire. MASTEROFFOXHOUNDS settled off the pace, rallied on the turn, challenged three across, assumed command, inched clear and was caught near the wire in a good effort. GORILLA TREK was void of early speed, swung wide entering the stretch and finished well to earn show. FOOTPRINT was never far back, rallied on the turn, went six wide entering the stretch, bid and came up empty. SONYA KNOWS BETTER was slow early, closed inside and improved position. FAST CONNECTION raced mid pack, swung wide entering the stretch, closed willingly, lost his path near the sixteenth pole, was steadied and stopped. HIDDEN PROFIT set a pressured pace to the second turn, weakened in the drive and faded. INTERLUDE was not a factor. MAX IS G MONEY pressed the pace two wide, challenged between horses on the second turn, dropped back and gave way. YOCKEY'S DRIVETHRU was steadied into the first turn and outrun in an even effort. THE RIDER OF FAST CONNECTION CLAIMED FOUL AGAINST THE RIDER OF FOOTPRINT FOR

ALLEGED INTERFERENCE IN LATE STRETCH. NO CHANGE WAS MADE.
