FLASH OF FIRE set a pressured pace from the inside, was in a long sustained drive and proved best in the end in a game effort. RUN THE STREET pressed the pace while two wide on the turn, was in a long drive but came up empty in late stretch. ARICELI ACES was settled then rallied four wide on the turn, was making a run then was squeezed in upper stretch then angled inside to be gaining in late stretch to finished strong. AWESUGARSUGAR chased the early pace while three wide into the turn, made a bid then weakened in the stretch drive. KATHLEEN'S ACE rallied four wide on the turn making a bid in the stretch, bore out in late stretch then hung in the end. CANDY GIRL MISS was unhurried early while four wide into the turn turn, rallied and moved out to be six wide for the stretch, was making a bid then was blocked in late stretch and forced to angled out and lacked a late response. SUGAH GEM rallied five wide on the turn making a bid but flattened out in the drive. DAT'S A GOODE ONE was unhurried early and failed to menace. MIDNIGHT CIGARETTE chased the early pace while three wide into the turn, was used up then stopped in the stretch. A claim of foul was lodged by the rider of CANDY GIRL MISS
