FINAL RUN FOR LOVE was unhurried early, roused from the inside on the far turn and from the four path at the top of the stretch was kept to task. WOLF BEACH tracked the early leaders, raced evenly from the inside on the far turn and had the lead in deep stretch but was outgunned. ARAMI'S SPEIGHSTER set the pace and had the lead on the far turn but was headed in mid stretch and gave way. ZIMBAWEE stalked the early leader and was a factor on the far turn but from the five path at the top of the stretch leveled off. FREE CHARGING was off the pace and saved ground on the far turn but from the five path at the top of the stretch was not a factor. RHUMBABA was in tight on the first turn, chased on the far turn and from the six path at the top of the stretch had no impact. A CLAIM OF FOUL BY THE RIDERS ON RHUMBABA AND FREE CHARGING AGAINST WOLF BEACH FOR INTERFERENCE IN THE FIRST TURN RESULTED IN WOLF BEACH BEING DISQUALIFIED AND PLACE SIXTH.
