THE TOWN TEMPTER took command shortly after the start, came under heavy pressure through the turn, pulled away a few lengths in the upper stretch, just held off late rally. CANDY TALKING bumped by foe at the start, raced off the pace, gained along the inside of the stretch, tipped out at the eighth and continued to rally but came up just short. VELCAMP trailed in the early stages, moved up between foes in the turn before taking towards the outside of the stretch, rallied for the show award. SHE'S A LIVE WIRE tracked the pace three wide, steadied in the upper stretch, finished well. COLLECTIVE BEAUTY found position around the middle of the pack, angled out six wide at the quarter, could not rally. DALE'S BLUFF was rated along the inside, flattened out in the stretch. FRONT RUNNIN moved up to apply pressure through the turn, drifted out in the stretch, weakened. UNDISPUTABLE raced in the middle of the pack, retreated at the quarter. NO TIME LEFT broke inward to bump inside foe, raced off the pace, never threatened.
