PENEI was bumped at the start, trailed for most, cued along the outside of the far turn, took command at the three sixteenths before settling in to the four path, ducked out a couple paths briefly approaching the sixteenths but was quickly corrected, dug in to secure the victory. NO REMATCH was unhurried at the start to settle in an off pace position, began to make progress four wide in the far turn, rallied seven wide down the stretch but just missed. SHARP STRIKE was allowed to settle off the pace, split foes a the quarter before claiming the inside of the stretch, rallied along the inside under left handed urging to earn earn the show award. PYROMANIA raced off the pace three wide, began closing in the far turn to enter the stretch just behind the pace, tipped out six wide but was unable to rally, passed tiring rivals for an improved position. BYWORD settled off the pace, moved into the middle of the pack going up the backstretch, split foes in the far turn to find a prominent position in the stretch, split foes once more in the upper stretch to press the pace but faltered in the final stage. OLIVERIO was bumped at the start, tracked the early pace three wide, cued up to contest the lead in the far turn, led briefly in the upper stretch before giving way to the winner at the three sixteenths, faded in the final sixteenth. WESTEROS pressed the early pace under a tight hold from the rider, took charge at the three quarters, continued on until finally coming under a loose rein at the three eighths, had no more to give in the stretch and stopped. RODAVLAS set a pressured pace under a tight rein from the inside, conceded the lead at the three quarters, chased the pace going up the backstretch until beginning a slow retreat in the far turn to trail the rest of the way.

SPECIAL AWAKENING was squeezed back at the start, raced off the pace, began closing in along the inside of the far turn and upper stretch, tipped out four wide approaching the eighth, continued to rally in the final furlong and got up just in time. MULA chased the early pace along the inside, split foes a the quarter to take charge by the three sixteenths, drifted out a couple paths under left handed urging inside the eighth, switched to right handed urging for the final sixteenth but got nailed by driving foe. FLASH OF CHAOS was pinched back at the start, trailed after the first turn, cued five wide in the far turn, continued to rally well along the outside of the stretch but was held at bay by the top two. STRAITSHOOTINLARRY tracked the early pace three wide, drifted out in the upper stretch and narrowly avoided contact with FLASH OF CHAOS at the eighth, repositioned along the inside of the final sixteenth, flattened out. CHASING GRAY quickly set an uncontested pace under a tight rein, continued on until being asked by the rider at the quarter but had nothing left to give in the stretch. ATHLETIC LIKE false broke in the gate just before the official start, held onto by the assistant starter momentarily before hopping and being allowed to join the pack, trailed through the first turn, moved up off the pace three wide, came up empty on the second turn and dropped out. GOLD DOLLAR found position in the middle of the pack, started a slow retreat in the far turn to trail by the sixteenth. STEWARDS INQUIRY REGARDING THE START FOCUSING ON ATHLETIC LIKE RESULTED IN ATHLETIC LIKE BEING DECLARED A STARTER AND NO CHANGE WAS MADE.

FLYING MOHAWK was bumped at the start, trailed through the first turn, steadily advanced along the inside, split foes in the far turn before making a seven wide bid at the top of the stretch to surge past the competition, just held off late driving foe. ORIZZONTE broke a step slow, raced off the pace, trailed after the first turn, took towards the far outside of the stretch to show an impressive drive that just missed. PINELAND broke slightly inward to bump foe at the start, chased the early pace from the inside, launched a four wide bid at the quarter and brushed FOLIGNO in doing so, led very briefly before giving way to the winner at the eighth. FOLIGNO tracked the pace between foes, brushed out by PINELAND at the quarter, continued five wide down the stretch but had no closing bid. CULTIVATE found position around the middle of the pack, closed some ground on the inside of the upper stretch before tipping out five wide at the eighth but could not continue the rally. THE PROCESS saved ground to apply pressure to the early pace three wide, vied for command through the far turn before taking charge at the quarter, gave way approaching the eighth and retreated then on.
