TYRONA prompted outside of the leader before vying in the three path around the turn, dueled through upper stretch, drove clear at the furlong grounds and held sway under firm handling. COTTON CANDY ANNIE tracked along the inside, took contact from an outer rival entering the turn, brushed an outer foe while moving to the three path passing the three sixteenths pole, gained place between rivals in the final furlong and was second best. DIXIE MORNING chased two wide and between horses, brushed an inner rival while dropping back into the turn, moved out to the four to five path in midstretch and ran on outside of rivals to reach show at the wire. REBA ATTACK was brushed by an inner rival at the start, trailed before advancing in the four path into the turn, chased outside of the top pair while within range around the bend, but took contact from an inner rival while yielding at the three sixteenths pole and lost show at the wire. HURRICANE LASSIE vied for the lead inside of the eventual winner, took the turn in the two path, dueled through upper stretch, but gave way at the furlong grounds and weakened.

BRANZINO broke a step slow, recovered to stalk outside of the embattled leading pair into the turn, issued a bold challenge at the five sixteenths pole, gained an advantage while lugging to the fie path entering the lane, drifted inwardly in upper stretch, put an inner rival in tight quarters at the three sixteenths pole, then held sway under a drive. MOTOWN STAR vied for the lead inside of a prompting rival, got outkicked by a wider bidder nearing the lane, took contact from his earlier sparring counterpart when that one was put in tight at the three sixteenths pole, kept on to offer a rebid inside of the leader in the final furlong but was fended off. GOOD TO BE PRINCE vied two wide, got outkicked by an outer bidder leaving the five sixteenths pole, but was forced to bump an inner rival when put in tight quarters by that outer bidder at the three sixteenths pole, altered out, recovered and sustained pursuit through the final furlong but missed place at the wire. WEDDING GIFT leaned outwardly leaving the gate and was slow to recover, raced well back along the inside, then improved position. SHRINER chased the leading trio from the two path and weakened. DOES NOT COMPUTE trailed two wide and showed little. THE RIDER AND TRAINER OF GOOD TO BE PRINCE CLAIMED FOUL AGAINST BRANZINO ALLEGING INTERFERENCE IN UPPER STRETCH. FOLLOWING THE OBJECTION, AS WELL AS A STEWARDS' INQUIRY, BRANZINO WAS DISQUALIFIED AND PLACED THIRD.

WILLTORUN stalked close up along the inside, awaited room from the pocket turning for home, committed to charge up the vacated rail in upper stretch, bid inside of the leader at the furlong grounds, dueled through the late stages and prevailed. TALONS TIME set a pressured pace in the two path, braced for an inner challenge in midstretch, dueled with that bidder through the final furlong but was bested. WENT WEST tracked from midpack in the three path, swung out five wide entering to take aim outside of the main group entering the lane, but only offered a mild kick and reached show at the wire. BOSS' DIALIN IN pressed the leader from the three path and between horses, failed to sustain pressure and chased an inner pair into the final furlong then got nailed by an outer bidder for show. CORTESE stalked outside of the top pair and from the four path, chased between rivals in upper stretch and yielded. SEEKING SAWYER broke a step slow, trailed in the two path and made little impact. SUPREMEPLY pursued from the four to five path ad was eased through the lane.

FLYING MOHAWK bobbed at the start, trailed along the inside, shifted to the four path and between horses while building momentum in upper stretch, rallied to bid along with an outer rival at the furlong grounds and drew clear under mild urging. STATES' RIGHTS bumped with rivals on both sides at the start, brushed with an outer rival while settling two wide and between horses, took the far turn in the three path, swung out to the six path entering the lane, rallied to bid along with an inner rival at the furlong grounds, but got outkicked by that one and held place from an inner challenger. HOT PROPERTY leaned inwardly and bumped with an inner rival at the start, pursued from midpack while tucking to the inside around the first turn, saved ground around the far turn, ran on with a rail grind to bid for place in the final sixteenth, but was denied. LUCKY MISCHIEF stalked along the inside, tipped out to the three path to take aim outside of the leader in upper stretch, bid before getting outkicked by an outer pair at the furlong grounds and yielded. EXECUTOR showed the way along the inside, held sway in the two path in upper stretch, but got headed by rivals at the furlong grounds and faded between horses. OPTICAL broke a step slow and was bumped by an outer rival leaving the gate, brushed with an inner rival entering the first turn while laying off of the pace three wide, took closer order before tracking outside of rivals around the far turn, but fanned out to the five path entering the lane and weakened between horses in upper stretch. DATE THE PRINCE stalked two wide, drifted out to the four path entering the lane, but shifted back inwardly shortly after and weakened between horses.

SWEET DARLIN was brushed by an inner rival into an outer rival at the start, stalked along the inside, tipped to take aim outside of the leader in upper stretch, gradually progressed to bid at the sixteenth pole and edged past. WUPKAR showed the way in the two path, maintained a clear margin through midstretch but was bested by an outer bidder late. MO FOR US took light contact from an inner rival at the start, laid off of the pace along the inside, awaited racing room in the two path behind foes into the lane, then ran on to edge show from an outer foe late. ROYAL O'HAIGAIN pressed the leader from the three path under consistent urging, then yielded through the lane. PLATINUM MINIT raced off of the pace in the four to five path and ran on one paced. COUNTRY LADY tracked in the four path and gave way between horses. SWEET ALEXIS brushed an outer rival leaving the gate, trailed in the three path and failed to factor. A RUNNIN AFLEET pursued from midpack in the three to four path and between horses, shifted out entering the lane and faded.
