SIERRA NOVEMBER off step slow, settled to half, boxed in upper stretch, no match for the winner into the lane, second best. BRACELET rated early, tracked three wide to half, asked four wide upper, not enough in the stretch, gained third. PARIS LILY sent, set contested pace to half, confronted to the quarter, faded lane.
