MARLIN DARLIN broke in at the start, assumed command, set pace inside to quarter pole, kept to task stretch, held safely late. OCEAN'S APPEAL bumped start, tracked early pace between two wide, shuffled into turn, fought on along the rail into the stretch, could not reel in the winner late and was second best. BRONZE LEGACY crowded start, tracked early pace inside, chased two wide into stretch, outkicked final sixteenth, clear third. PEACE OF JUSTICE squeezed start, chased four to five wide to quarter, no late kick. NOTHIN awkward start, coaxed between foes and three to four wide to quarter, weakened stretch. GO HOT GIRL settled between three wide, shuffled into turn, no late rally. HAMMYDOWN hustled, pressed to turn, gave way to quarter, eased stretch, walked off.
