R T'S GEM broke in at the start, assumed early command, set a decent pace to the half-mile marker, drew clear to the quarter pole, held sway to mid-stretch, ridden out in the final stages. INCOGNITO BURRITO close up three wide in the early going, tucked in into the backstretch run, chased the winner to upper stretch, could not make headway in the drive and was second best. PICKIN ANA GRINNIN crowded at the start, made a three to four wide move to the half-mile pole, chased three wide to the quarter, flattened out in the lane, held for third. DIVA BEACH hit gate, crowded at the start, settled to the half, asked four wide upper stretch, no late kick, just missed for third. SWAMP QUEEN unhurried to the backstretch, saved ground to the quarter marker, no late kick. BOX OF PICTURES settled outside, coaxed four to five wide to the half-mile, lacked the needed response into upper stretch, weakened in the drive. JUS EVELYN close up early, stalked the decent pace to the half, no response nearing the quarter pole, came up empty in the stretch. THE TRAINER OF PICKIN ANA GRINNIN LODGED AN OBJECTION AGAINST THE JOCKEY OF R T'S GEM, CLAMING INTERFERENCE AT THE START. THE STEWARDS DISALLOWED THAT OBJECTION AND RULED THERE WOULD BE NO CHANGE.
