PARDONED sat behind the early pace, loomed three wide through the turn to take command at the quarter, drew clear to be much the best. ANDYS PLAN B settled off the pace, picked off rivals seven wide in the stretch to earn the place award. BIG MO settled off the pace, improved position six wide through the stretch for the show. BELLASTONE COUNTRY was bumped at the start, vied for the early lead from the inside, backed off entering the turn, angled out four wide in the stretch but came up empty. DEAL ME TRIPS was bumped at the start, vied for the early lead, took command in the turn, conceded to PARDONED at the quarter, weakened in the stretch. DULCE LOREFICHE was bumped at the start, raced off the pace, passed tiring foes in the stretch. DAYOFTEWARRIOR was bumped at the start, found position not too far behind the pace, retreated in the stretch. MAKE ME A DEAL was off slowly, trailed for most, passed tired foes along the inside of the stretch. SPIRITUAL DUTY broke outward to bump rivals at the start, raced along the inside, slowly retreated. THINE RUCKUS found position around the middle of the pack, closed some ground in the turn, retreated soon after.
